

# Florida Wing Members Support Special Olympics Airlift by Maj. Sybrian Castleman, FLWG Public Affairs

Florida Wing Civil Air Patrol members arrived before dawn on June 4<sup>th</sup> to support the Special Olympics Airlift, sponsored by Textron Aviation, at the Orlando Executive Airport to greet athletes upon their arrival to Orlando for their week of competition in the 2022 USA Games.

This was an amazing, fun-filled day as volunteers cheered athletes from the moment they stepped off the aircraft to the welcome center where they were greeted by more cheering, dancing, and clapping. Florida Wing members also assisted with loading the incoming athletes' baggage into trucks to be transported to their hotels helping make this complex operation run smoothly.



It was a memorable day for athletes, coaches, and volunteers. Football Hall of Famer Peyton Manning was at the event for photo opportunities and to show his support for the athletes. Civil Air Patrol's chief operating officer, Southeast Region Commander Col. Andrea Van Buren and Florida Wing Commander Col. Luis Negron were also in attendance, helping greet athletes and visiting with Florida Wing members throughout the day.

Overall, 60 Florida Wing members supplied over 400 volunteer hours during the Airlift with nearly 80 planning hours contributed by Capt. Michael Piwowarski, Activity Director; Maj. Ayrton Ingle, Incident Commander; and their advance planning team. About twice as members originally volunteered to support the Airlift, but as Tropical Storm Alex approached and threatened the southern part of the state, many Florida Wing members were unable to attend.

"We had a few showers and some drizzle for most of the day but it didn't dampen the spirits of the arriving athletes or any of the volunteers who made them feel very welcome," said John Salvador, CAP's chief operating officer. "Our cadets played a huge role in welcoming the athletes at the hangar where they gathered after arrival."

# **Tropical Storm Alex**

In early June, parts of Florida Wing rapidly advanced through HURCON levels in anticipation of Tropical Storm Alex. Many storms give us a lot of time to prepare, while others develop quickly, leaving little time to put a plan into action.

Fortunately, there was little impact from TS Alex and it gave Florida Wing members an opportunity to complete tasks to secure buildings, vehicles, aircraft, and other assets - and to discover if local storm preparedness plans or unit contact lists needed to be updated or revised.



## What's new in the HURCON FLWG Plan?

One of the first items you may notice as you read through the plan or check the 2022 FLWG HURCON Status on the wing website is that the wing is currently at HURCON 5. HURCON 5 is a seasonal alert condition that is automatically set by all units in FLWG from 1 June through 30 November each year unless directed otherwise by the Florida Wing Commander.

The 2022 Florida Wing HURCON Plan is available on the FLWG website. Please become familiar with the plan and the SITREP procedure. It is recommended that you review the plan with members of your unit, discuss local plans for securing assets and maintaining communication with unit members if your area is affected by a storm.

#### **DESCRIPTION**

Florida Wing is hosting a Southeast Region Cadet Leadership School from 31 Jul to 6 Aug 2022 at the Tri-State Christian Camp (TSCC) in DeFuniak Springs, Florida. The Region Cadet Leadership School is a weeklong activity for Cadet Officers and Senior NCOs that expands and builds upon leadership skills already familiar to experienced cadets.

The goal is to impart both academic knowledge and tools for practical application which will make participants more effective both in CAP and in life. The RCLS program has been expanded to a full week so that the curriculum more closely parallels that found at the National Cadet Officer School. Attendance at a RCLS is a requirement for the Eaker Award.

#### **ELIGIBILITY**

To be eligible to attend RCLS the cadet should be an officer or an NCO at or above the grade of Master Sergeant, and have completed a basic encampment. Seniors participating as staff should have extensive experience with the cadet program. Cadets who have completed the national Cadet Officer School or who have earned the Spaatz award may also apply for staff.

CAP members - Do you want to be involved in a disaster response, regardless of where you live? Have you always wanted to serve during a mission but felt you don't get the opportunity because disasters don't occur where you live, you don't fly, or you're not a member of a specialized team?

Things are changing. Did you see this article on "Harnessing Technology" in the Spring edition of Civil Air Patrol Volunteer? This past year, CAP helped assess damage from Hurricane Ida; tornadoes in the Quad States, New Orleans, and Andover, Kansas; and New Mexico's Hermit Creek Fire.

You now have the opportunity to support FEMA by helping conduct imagery-based damage assessments. On behalf of the CAP Geospatial Program, all members, including those from our international squadrons, are eligible to apply and help.

You must complete the training to be eligible. You may be called on to support a disaster response (to hurricane, fires, tornadoes, floods, etc.), regardless of where you live. To sign up and help, <u>see these details.</u>


Cadet Wings -158th Cadet to Earn Private Pilot Certificate

# **Change of Command Held for Civil Air Patrol Cadet Squadron**

Changing command is a time-honored ceremony steeped in military tradition. The Charlotte County Civil Air Patrol (CAP) cadets participated in that tradition during a ceremony at the squadron's building in Punta Gorda on Monday, May 23, 2022.

During the event, the incoming cadet commander, Cadet 2nd Lt. Alexandrea Mulvaney, took the reins of the squadron, while outgoing commander, Cadet Capt. Riley Pezdek, reflected on her tenure.

Mulvaney is a third-generation CAP member and credited her grandfather as the inspiration for joining the Punta Gordabased squadron. She acknowledged the valuable camaraderie she gained through participation in the program.

"The best part is the friendships and family I've gained," Mulvaney said. "I consider them all my CAP brothers and sisters."



As commander, Mulvaney said her goals for the next year are to increase cadet recruiting and retention efforts, develop new activities and foster the camaraderie in the squadron.

Reflecting on her term as cadet commander, Pezdek praised the cadets' dedication during the recent pandemic challenges, "I am so proud of you all," she said. "Without you, there wouldn't be a squadron."

The recent North Fort Myers High School graduate spoke about her upcoming attendance at Florida State University and pledged to visit the squadron again. "This is good night, not goodbye," Pezdek said.

Please update your email signature lines, business cards, social media, and other places where your unit has the old CAP logo (this is the white triangle with red three blade prop) with the new logo. Banners and other printed materials should be updated as soon as possible, but NHQ is allowing for a phase-out/phase-in as noted below under "Legacy Marks." A suspense date for the Legacy Mark provision has not been provided at this time.

The information below can be found in the CAP Branding Portal along with templates for email signature lines, business cards, and more detailed information about how/when/where to use the new logo. A couple of additional notes: The Civil Defense-based Tri-blade has not been replaced for heraldry, historical applications, and where the Command Emblem, Roundel, and/or Official Seal are authorized for use. The Command Emblem, Roundel, and Official Seal have not been changed or replaced.

# Symbol

The primary symbol is a blue winged "V" known as the "Flying V." This symbol replaces all previous versions of the Civil Defense-based Tri-blade symbol in all commercial applications except for heraldry and historical applications, uniforms, and where the Command Emblem, Roundel, and/or Official Seal are authorized. The Flying V and all variants of the symbol, wordmark, and logo are a registered trademarks of the corporation and may not be used without express permission.

## **Acceptable Use**

The CAP Symbol is the basic visual brand identity element of the brand. It is appropriate for application incorporated into every mark and emblem that the corporation uses. It may be used as an opaque watermark on photos, video, and illustrations. The CAP Logo will be used when the name and symbol are displayed together. Use of the CAP Symbol as an avatar or profile photo on social media sites is limited to HQ CAP or with approval from CAP/PA.

## **Unacceptable Use**

The CAP Symbol will not be used in isolation without the Civil Air Patrol name within visual reference. It will not be altered or manipulated in any form. No text or graphics will overlap the CAP Symbol.

#### **Legacy Marks**

Previous CAP symbols may continue to be displayed if there is a monetary barrier to updating the use. All digital assets must be updated.

# Logo

When the CAP Symbol is paired with the CAP wordmark it is the official Logo and a trademark of the Corporation. The wordmark is based on the Rajdhani typeface but has been modified to ensure it is unique to CAP. The CAP Logo may only be displayed in the manner and configurations listed in this guide. Use of the horizontal layout is preferred.



# **Acceptable Use**

The CAP Logo will be used on all websites, social media, magazines, newsletters, recruiting material, activity programs, advertising, presentation slides, business cards, email signatures, exhibits, facility signage, and any other item that represents any aspect of the organization. The Logo will be used as a bumper at the end of all video content produced and used for CAP business; animations of the logo are not authorized unless provided or approved by CAP/MAC.

In all instances, the CAP Logo will take the place of prominence when used with other logos or with region, wing, or unit graphics. When CAP is the host or primary activity, no logo will be larger than the CAP Logo.

## **Unacceptable Use**

The CAP Logo will not be modified or altered in any way. Do not add effects like a shadow, stroke, or glow unless approval has been obtained from CAP/MAC. CAP/MAC must approve all non-CAP use of the logo. Animations of the logo are not authorized unless provided or approved by CAP/MAC.

#### **Legacy Marks**

Previous CAP logos may continue to be displayed if there is a monetary barrier to updating the use. All digital assets must be updated.
